12. I am aware that to be a member I am liable for the following costs\*:
  - a. Police clearance, car stickers, renewal of membership and reissuing of membership card:+-R70 per person (annually)
  - b. Purchase of radio unit. The costs vary depending of the model. This is a once off cost.

(\*Please note that the costs quoted may change from year to year. The above is just a current estimation. CPF may amend these costs as when required.)

13. I acknowledge that at any stage during my valid membership the CPF may conduct an additional police clearance search, at their own cost and without my prior knowledge, to ensure the compliance of their members. I acknowledge this right and give such authority.
14. As a member of the organisation I acknowledge that any confidential information that is shared amongst its members via our Radio Network, e-mail, telephonically etc is not to be disseminated to non-members, media and or Press. Should it be determined that I have transgressed this confidentiality, it will be deemed to be a negligent act and can result in my dismissal and expulsion from the Kempton Park CPF. This especially refers to my family and friends that may be in proximity to my radio, however this includes the general public as well.
15. The radio frequency utilised by the Kempton Park CPF is the express property of the CPF and on cessation of my membership I acknowledge that I have 7 days to have my radio frequency decommissioned. Any cost incurred will be for my account. I note that failure to comply with this can and will result in a costly legal remedy.
16. Under no circumstance may I lend or permit a non member to utilise my radio except immediate family members that reside at my premises and then only in an emergency.
17. I will in the execution of my voluntary service to the residents and business in the area act within the framework of the law and the Gauteng Provincial Constitution and Code of Conduct for CPF structures.
18. I am aware that I am personally liable for my actions during such voluntary service and indemnify the KPCPF against any consequences arising out of my actions.
19. All of the information contained in this document is correct to the best of my knowledge. I accept that should any information come to your attention that may be relevant to this application, but not declared by me, the CPF hold the right to cancel my membership with immediate effect.
